SUBJECT: FY18 Configuration Steering Boards (CSB) Program Exemption Memorandum

Section 826 of the National Defense Authorization Act (NDAA) for Fiscal Year (FY) 2018 (Pub. L. 115-91) amended the CSB meeting requirements in 10 U.S.C. § 2430 note. Specifically, it allows the SAE to waive the requirement for a CSB if the Major Defense Acquisition Program had no requirement changes in the previous year.

The Air Force Program Executive Officers (PEOs) identified MDAPs in their portfolios with no requirement changes and these programs are listed in Attachment 1. The PEOs also identified MDAPs that are required to come forward for a FY18 CSB, and these programs are identified in Attachment 2.

This memo serves as the documentation required by the NDAA to not hold FY18 CSBs for those programs indicated in Attachment 1. Please forward any questions or concerns regarding the CSB exemption to Dr. Stanley Armstead (stanley.k.armstead.ctr@mail.mil).
