1) I have reviewed the documents. While they are legally sufficient I have the following comments:

Eval Criteria, para 1.1, note after discussions with Della, we have three other proposed language to use regarding interchanges vs the "all some or none" language

- a) After evaluating all proposals and assessing their relative qualities [this is FAR 15.305(a) language], interchanges, if determined necessary [gets to the none], will be conducted only with the offeror(s) that the Agency assesses as capable of providing the best value to the government. OR
- b) After evaluating initial proposals (there may be instances where we have included down select language) and assessing their relative merits, interchanges, if determined necessary, may (instead of will) be conducted with only the offeror (s) that provides the most highly rated proposals and are capable of providing the best value to the government. OR
- c) After evaluating initial proposals (there may be instances where we have included down select language) and assessing their relative qualities, interchanges, if determined necessary, may (instead of will) be conducted with only the offeror (s) that are determine to be within the competitive range. A competitive range determination will consist of the most highly rated proposals and those that provide the best value to the government.
- 2) Eval Criteria, paga 2.1 states, "The Technical proposal shall not contain any pricing data." Would we want to caveat this that "Offerors can provide general pricing strategies or experience regarding the hiring and retention of person; however, this information will not be used by the price evaluation team." We have run into an issue in other procurements where we ask for this information to show prior experience at the lower wage rates and offerors tell us, "but you told us not to include pricing in technical." Just something to consider.
